Official Rules

- 1. Raffle. 2017 New England Patriots Day Trip to Super Bowl LI Raffle (this "Raffle").
- 2. <u>Raffle Period</u>. This Raffle begins at 9:50 p.m. on Sunday, January 22, 2017, and ends at 11:59 p.m. on Tuesday, January 31, 2017 (the "Raffle Period").
- 3. <u>Eligibility</u>. Raffle only open to individual legal residents of the fifty (50) United States (excluding CA, FL, NY, Puerto Rico, territories and possessions) who have attained the age of majority in their state of residence as of the date of entry into the Raffle. Employees of the New England Patriots Charitable Foundation Inc., the Kraft Group Companies, and each of their respective affiliates, officers, directors, employees, agents, advertising, public relations and promotion agencies, the judges, and members of each of their immediate families (i.e. spouses, parents, children and siblings, and their respective spouses) and those living in the same household of each are not eligible to enter.

Upon entry, entrant will receive a receipt which shall constitute a ticket for the purposes hereunder. Sponsor may require entrant to present the receipt in order to claim prize.

- 5. <u>Prizes and Odds</u>. There will be one (1) Grand Prize Winner. Sponsor reserves the right to substitute prizes of equal or greater value. Odds depend on the number of eligible entries received.

- 6. <u>Selection of Winner</u>. One (1) winner will be determined from all eligible entries received during the Raffle Period in a random drawing to be conducted as soon as practicable following the close of the Raffle Period. The drawing will be conducted by the Sponsor, whose decisions are final on all matters relating to this Raffle.
- 7. Prize Delivery and Winner Verification. Sponsor responsible only for prize delivery; not responsible for prize utility, quality or otherwise. Winner will be notified by telephone and or email. If a potential winner cannot be reached by telephone and/or email within a reasonable time of the drawing or is ineligible, the prize will be forfeited and an alternate winner selected. Winner will be required to sign and return an affidavit of eligibility, prize acceptance form and applicable tax documentation. Each Winner may be required to sign an affidavit of eligibility and liability release and, where permitted, a publicity release. By participating, entrants hereby release and agree to hold harmless the New England Patriots Charitable Foundation Inc. and the Kraft Group Companies, and each of their directors, employees, officers, and agents, including without limitation, their advertising and promotion agencies, from any and all liability, loss or damages arising from or in connection with the awarding, receipt, and/or use or misuse of prize or participation in any prize-related activities.

This Raffle will be governed by the internal laws of the Commonwealth of Massachusetts. Any and all legal actions or claims arising in connection with this Raffle must be brought in a court of competent jurisdiction within the Commonwealth of Massachusetts. Except where prohibited by law, each entrant agrees that: (i) any and all disputes, claims and causes of action arising out of or connected with this Raffle or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by state or federal courts situated in Boston, MA, (ii) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, but in no event attorney's fees, (iii) no punitive, incidental, special, consequential or other damages, including without limitation, lost profits, may be awarded (collectively, "Special Damages"), and (iv) entrant hereby waives all rights to claim Special Damages and all rights to have such damages multiplied or increased.
