

## 2009 New England Patriots Charitable Foundation License Plate Raffles

### **Official Rules (ONLINE)**

1) **PRIZE-** Each winner of these raffles will be awarded a priceless, one-of-a-kind, custom designed New England Patriots license plate featuring one of the following: (1) the number "14"; (2) the number "20"; (3) the number "57" or (4) the number "87" ( the "Special Patriots Plates"). The prizes will be awarded via a random drawing conducted on or about January 31, 2010. Each raffle ticket is for a specific prize. Potential winners must be available to take possession of the prize at a time and place convenient to the New England Patriots Charitable Foundation Inc., and the Massachusetts Registry of Motor Vehicles. All taxes charges and other expenses not expressly listed in these rules as being part of the prize are the sole responsibility of the winners. Winners will be responsible for all applicable state and federal income taxes as well as all additional fees and charges regarding this license plate per the Massachusetts Registry of Motor Vehicles. Winners will be notified by telephone and or mail. If a potential winner cannot be reached by telephone and/or mail within a reasonable time of the drawing or is ineligible, the prize will be forfeited and an alternate winner selected. Winners will be required to sign and return an affidavit of eligibility, prize acceptance form and applicable tax documentation. The New England Patriots Charitable Foundation Inc. will send the prize documentation to the potential winners once they are reached and eligibility is confirmed. Winners must return signed affidavit and documentation within five (5) days after receipt. The prizes will be awarded after receipt of the completed prize documentation and verification of eligibility. If the applicable affidavit and documentation are not returned within five (5) days of receipt, the applicable prize will be forfeited and an alternate winner selected. The New England Patriots Charitable Foundation Inc. reserves the right to change any of the prizes to another license plate with a comparable two-digit number.

2) **ELIGIBILITY-** Open to all operators of Massachusetts-registered vehicles. Void where prohibited or restricted by law. Employees of the New England Patriots Charitable Foundation Inc., New England Patriots LP, NPS LLC, and each of their respective affiliates and subsidiaries and their immediate family members and/or those living in the same household of each are not eligible to participate.

3) **CONDITIONS OF PARTICIPATION-** Participant agrees a) that New England Patriots Charitable Foundation Inc., New England Patriots, NPS LLC and their parents subsidiaries and affiliated companies and all of their respective officers, directors, employees, representatives and agents will have no liability whatsoever for, are released, and shall be held harmless by participants against any liability for any injuries, losses or damages of any kind to person(s) (including death), or property resulting in whole or in part , directly or indirectly, from acceptance, possession, misuse or use of the prize or participation in this raffle and b) each winner grants permission to the New England

Patriots Charitable Foundation Inc. the right to use his/her name, photograph, likeness, image and biographical information for advertising, publicity and promotional purposes without additional compensation.

4) GENERAL CONDITIONS- The New England Patriots Charitable Foundation Inc. makes no warranty, guaranty or representation of any kind concerning the prize and disclaims any and all implied warranties relating to the prize. The prize will be awarded on an “as is” basis.

5) DISPUTES- All disputes concerning this raffle will be governed by and construed in accordance with the laws of the Commonwealth of Massachusetts without regard to its choice of laws or conflicts of laws provisions.

6.) Each winner must have an active passenger registration. Each winner’s registration and license cannot be in a non-renewal, suspended, or revoked status at the time the plate is registered. As such, a winner must not have any outstanding excise taxes, parking tickets, child support, warrants, or fast lane violations. Each winner must currently insure their registered vehicle.

7.) Each of the special Patriots Plates is not a valid registration plate until issued to the identified winner by the Registrar of Motor Vehicles as part of its motor vehicle registration process. All plates remain the property of the RMV.
